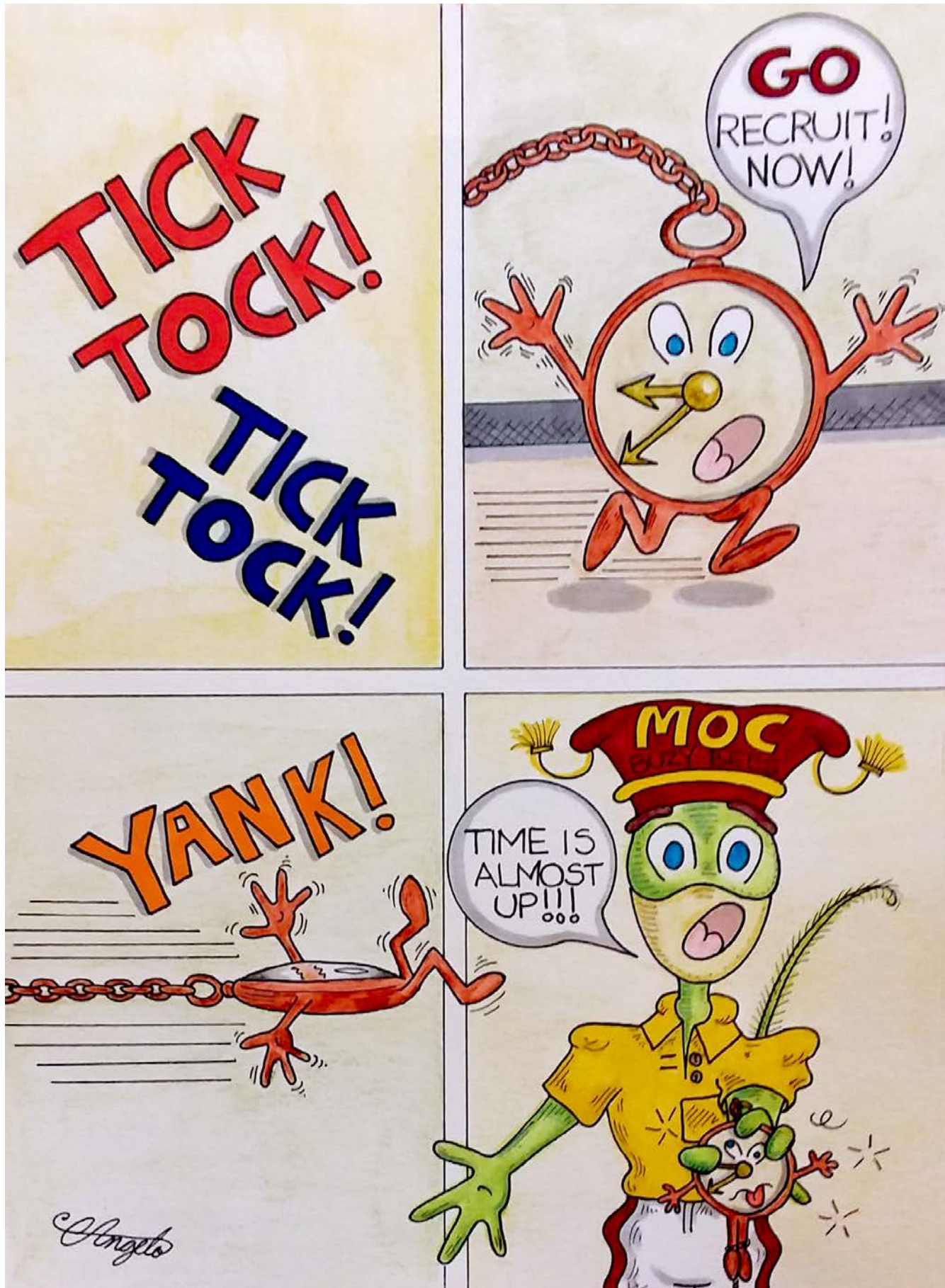

Listen Cooties

We are on the downhill stretch of the program year. First, I hope that everyone is doing well or at least better. This has been a challenging year, and we lost too many good Cooties and friends. But on the bright side we may be turning the corner and can look forward to better times. There are several things that need to be discussed.

Membership: The Supreme Commander, Sr. Vice and Jr. Vice have been out and about visiting Grands, and states where Cooties do not exist. Membership is the lifeblood of this organization and without it we cease to exist. If that happens who will take care of our sick and disabled comrades. To the CCDB's and Quartermasters: Please contact those Cooties that have not paid their dues and ask them to step up. I know that times are hard and in some cases money is short. The Grand of Texas is going out of its way to assist those Cooties that are having hard times by offering to pay their dues for this year. As the Supreme Quartermaster I will make the same offer. If you cannot afford to pay your annual dues, I will pay the Supreme per capita tax for you out of my pocket, you must figure out how to pay your Grand and Pup Tent per capita tax. Hospital chairman: You need to talk to your Cooties and have them file their hospital reports. I know that the work is being done, now it must be reported. Phone calls, meals provided, drive byes and cards sent to the sick all count as hospital work.

This is a bonding year with everyone's current bonds expiring on August 31, 2021. The cost is the same as last time you got a bond, \$14.00 per thousand and the bond is good for 2 years.

With everything going as it is, the Supreme Scratch will happen in Baltimore, MD at the BWI Marriott starting August 5th and going through August 8th. Please make your reservations early as we are at about 40% of our room quota. Please remember that each Pup Tent is required to register a delegate for the Supreme Scratch, even if they do not plan on attending the convention. Grand Commanders it is your responsibility to ensure that the Pup Tents register for the Supreme Scratch, especially if you want to cast your entire Grand's vote. Grand Commanders, it is also your responsibility to ensure that your Pup Tents are inspected. If your Grand is not at least 80% inspected, you have no vote. Along this same line if election reports are not sent to Supreme headquarters then the Pup Tent has no vote and Grand commanders will lose the number of votes associated with that Pup Tent. Grand Commanders I recommend you appoint someone in your Grand to verify that the Pup Tents send their election reports to the Grand Adjutant and to Supreme headquarters.

I am looking forward to seeing you in Baltimore in August. Our supply department will have some new items and of course some specials, bring lots of MONEY!!!

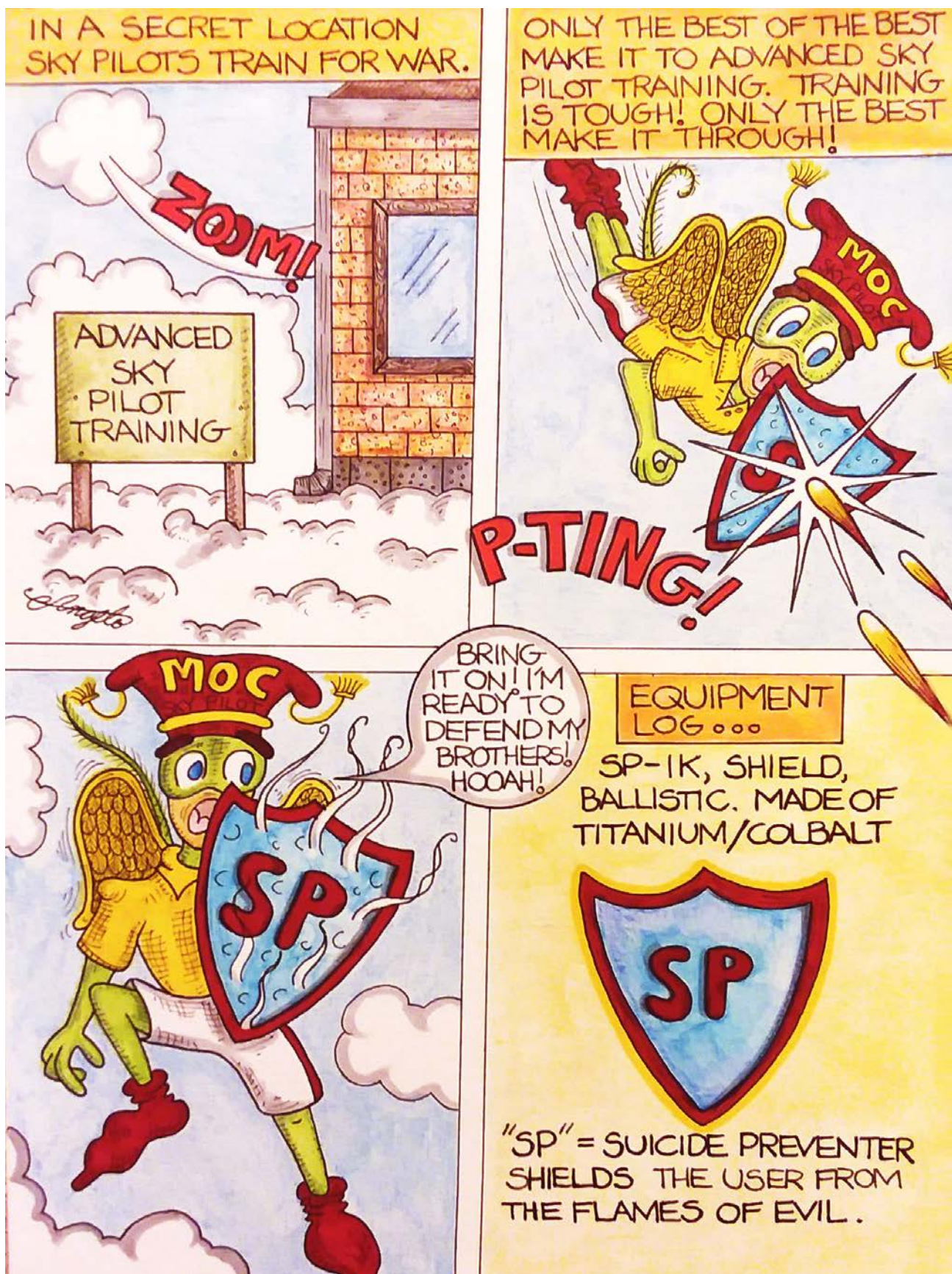

Who Can You Help by Donating Blood?

Every day, blood donors help patients of all ages: Accident and burn victims, heart surgery and organ transplant patients, and those battling cancer. In fact, every two seconds, someone in the U.S. needs blood. Here are just a few of their stories.

Cancer Patients Ideal Donation Type:

Platelets donation, because certain cancers and cancer treatments prevent patients from producing their own.

Ideal Blood Type

A positive, A negative, B positive, O positive, AB positive and AB negative

Trauma Patients Ideal Donation Type:

Power Red, because red cells carry oxygen throughout the body and are frequently given to trauma and surgery patients. AB Elite plasma donation, because AB plasma is needed to help stop bleeding. Call 1-800-RED CROSS to make an AB Elite appointment.

Ideal Blood Type

For Power Red: O positive, O negative, B negative, A negative

For AB Elite: AB positive, AB negative

Sickle Cell Patients Ideal Donation Type:

Whole blood, especially from African-American donors, because sickle cell patients require multiple transfusions and must be very closely matched to the donor's blood type, usually from the same racial and ethnic group.

Ideal Blood Type

O negative, especially from African-American donors

Burn Patients Ideal Donation Type:

AB Elite, because plasma helps maintain blood pressure and other vital functions.

Ideal Blood Type: AB positive, AB negative. Type AB, the universal plasma donor's blood can be given to any patient needing plasma. Make an even greater impact for patients in need by giving an AB Elite plasma donation.

Patients with Chronic Diseases Ideal Donation Type:

A single whole blood donation can help more than one person.

Ideal Blood Type: All blood types are needed.

From the Supreme Surgeon

Sunshine and Your Health

Spring is finally here and with it comes longer days and lots of sunny weather. We have all heard about the negative effects of the sun, but the sun also provides many benefits to your overall health.

It is recommended that you spend 10-15 minutes in the sun every day. According to *Healthy Living*, there are many benefits from sun exposure. Listed below are some of these benefits.



1. **Prevents Vitamin D Deficiency.** Sunlight exposure on your skin triggers the body to produce Vitamin D. Vitamin D, also known as the sunshine vitamin, is essential for your overall health. Vitamin D helps to naturally lower your blood pressure and increase brain function.
2. **Reduces Cancer Risk.** Vitamin D may decrease the risk of many types of cancer and increase survival rates.
3. **Lower Blood Pressure.** One way to lower your blood pressure is exposure to sunlight. During exposure to the sun's rays, Nitric Oxide, on the top layer of your skin, causes blood vessels to expand as the Oxide moves into the blood stream. This helps to lower your blood pressure.
4. **Improves Your Mood.** Serotonin levels increase when you are exposed to sunlight. Serotonin makes you feel happy and your mood improves.
5. **Improves Sleep.** The morning sun is linked to improved sleep and health.
6. **Weight Loss.** When you don't get enough sun, you can become depressed. Depression will affect your appetite. Hunger is controlled by the hypothalamus and works in conjunction with serotonin to decrease your hunger. When you have decreased exposure to sunlight, your serotonin level drops and you eat to satisfy your hunger cravings. By exposing yourself to sunlight, your serotonin levels increase and you are able to control your appetite and may lose weight.
7. **Better Bone Health.** Sunlight increases your Vitamin D levels. Vitamin D helps your body absorb calcium. Calcium increases your overall bone health.
8. **Improves Brain Function.** Sunlight directly affects the gland that produces melatonin. Melatonin is an antioxidant that improves sleep quality and helps prevent depression. A good night's sleep is important for your brain to function properly.

Let's try to commit ourselves to getting a little more sunshine every day. Take your morning cup of coffee on the porch and watch the birds, take a morning walk with someone and watch the day come alive or simply work in your garden to increase your exposure to the sun.

MOC General Order #4 2020-2021

1. All suggested by-law amendments and changes to the 2019 By-Laws and Ritual need to be submitted by 15 Feb to the By-Laws Review Chairman Marc Garduno (post3238cdr@gmail.com or snail-mail). Chairman Garduno will in turn forward to all appropriate board members. The deadline is so that there is adequate time to review, coordinate editorial changes (for grammar, syntax, format) and get them to the editor for publishing. Please include a name and contact information so that he can contact the correct individual to coordinate with them.
2. All Pup Tents are reminded to forward copies of Election Reports for the 2021-2022 membership year to Supreme Headquarters. Pup Tents without election reports for the *New Year* are not in good standing and may not be represented at either their Grand or Supreme Scratches. Pup Tents whose election reports have not been received 01 May 2021 may be suspended in accordance with the Supreme By-Laws and can be declared defunct if corrective action is not taken by 01 July 2021. While it is the duty of the Installing Officer to forward election reports, Seam Squirrels, both incoming and outgoing, should take it upon themselves to see that this procedure is carried out. **No Election Report = NO VOTE.**
3. Membership packets for 2021-2022 are in process and will be mailed in June 2021. They will be mailed to the Grand Quartermaster of record as provided on the Election Warrant. Grand Quartermasters are instructed to mail out the individual Pup Tent's packages to their respective CCDB's. Pup Tents that have not sent in an Election Warrant, have not secured a Bond for the office of CCDB, or have less than nine (9) members will not receive a packet until these discrepancies have been corrected.
4. All Grand Commanders are reminded that their Grand must be at least 80% Inspected to have a voice or vote at the Supreme Scratch. Please review the latest *Inspection Report*.
5. In accordance with provisions of Section 534 of the Supreme By-Laws, all Pup Tents are required to register, in advance, at least one delegate to the Supreme Scratch. Failure to register shall be grounds for the Pup Tent to be declared in arrears to the Supreme Pup Tent and appropriate action will be taken. Advance registration for the Supreme Scratch is \$15.00 and \$20.00 for registration received after 30 June 2021. **No Delegate fee = NO VOTE.**
6. 102nd Supreme Scratch and 59th MOCA Convention are to be held in Baltimore, MD at BWI Marriott located at 1743 West Nursery Road, Linthicum, MD. You can call the hotel at 410-859-8300 or use link on LOTCS.org. Please remember to mention Military Order of the Cootie Scratch in July 2021.
7. The 102nd Supreme Scratch Advertising Order Form and the Booster MUST be received by Headquarters No Later than June 15, 2021. Forms for both are on the Supreme website. You can also email your ad to Supreme Adjutant Gordon Lam – lams88101@outlook.com and

mail the form & check to Supreme Headquarters, 604 Braddock Ave, Turtle Creek, PA 15145. Be creative. Remember – all forms and money are sent to Supreme Headquarters.

8. **ALERT, ALERT:** All Grand Commanders, Supreme Council Members and Past Supreme Commanders, look hard at the Registration Form. If you want to have your own vote, register as such. If you register as a Pup Tent Member, that's what you are. If you plan on flip flopping votes, you will need to register more than once.

9. All Supreme Officers and Chairmen are required to submit in writing a report detailing their activities no later than thirty (30) days before the start of the Supreme Scratch. Reports are submitted to the Supreme Adjutant. Deadlines for submitting reports are 25 June 2021.

10. All Grands and Pup Tents are reminded that this is a Bonding Year. Current Bonds expire on August 31st.

11. The Grand Commanders and Quartermasters will receive one email towards the first week of June showing what information is missing from their respective Pup Tents. No Election Reports, No Inspection, No Convention Registration.

General Order #4 Series 2020 - 2021

- 1. Elections/Installations:** Auxiliaries, all elections and installations must be completed by March 31, 2021. Any installations required after March 31, 2020 must be approved by the Supreme President. Please send copies of all election/installation reports to Supreme President Jennifer Winn, Supreme Treasurer Penney Howard, and Supreme Secretary Georg Jean Zimmerman.
- 2. Congratulations** to all the newly elected Military Order of Cooties Auxiliary Officers and appointed chairmen. Remember that your term of office begins after the Grand has installed their new officers at Grand Convention. For those Auxiliaries not in a Grand the same applies to you once the Grand Pup Tent or in the case where no Grand PT exists, then it is concurrent with the Pup Tent. Also, **Congratulations to our newest baby Auxiliaries.**
- 3. All outgoing Officers and Chairmen:** It is your responsibility to turn over all records and paraphernalia to your successor when he/she takes office. Please assist your successor through *Mentorship* and wise council you gained through your experience during your term of office. It might be good to make yourself a file of all records turned over as a backup.
- 4. Delegates: Sec. 322 – Delegates to Conventions:**
 - a. Delegates and alternates to the Grand Convention shall be elected at a regular meeting of the Auxiliary held not less than thirty (30) days prior to the Grand Convention; one (1) delegate and one (1) alternate for each ten (10) members or fraction thereof in good standing in the Auxiliary at the time of the election.
 - b. Delegates and alternates to the Grand District Convention shall be elected at a regular meeting of the Auxiliary held not less than thirty (30) days prior to the Grand District Convention; one (1) delegate and one (1) alternate for each ten (10) members or fraction thereof in good standing in the Auxiliary at the time of the election.
 - c. Delegates and alternates to the Supreme Convention shall be elected at a regular meeting of the Auxiliary held not less than thirty (30) days prior to the Supreme Convention; one (1) delegate and one (1) alternate for each fifteen (15) members or fraction thereof in good standing in the Auxiliary at the time of the election.
 - d. Delegates and alternates to the Supreme District meeting shall be elected biannually at a regular meeting of the Auxiliary held not less than thirty (30) days prior to the Supreme District meeting; one (1) delegate and one (1) alternate for each fifteen (15) members or fraction thereof in good standing in the Auxiliary at the time of election.

- e. If any money is to be allowed to a Delegate attending the convention, a motion must be made before the election of said delegate. Please make sure that if your District/Grand/Auxiliary is paying a Delegate's way your representatives know that they need to attend all functions of the Convention.

5. Membership: As of 1/01/2021, the Supreme MOCA membership is 71.54%. This is prior to the Supreme Treasurer becoming ill. As Penney is still recovering and working on things, we will keep you posted. Remember to reach out to your current membership by contacting them via phone, letter, or personal visit to encourage them to pay their 2021 dues. Do not forget to invite VFW Auxiliary members to join the Military Order of the Cootie Auxiliary.

- a. **AUXILIARIES:** You need 10 current members with paid 2021 dues to be an Auxiliary in Good Standing. Please make sure you have collected and transmitted your members.

6. Treasurers: Please Do Not hold dues. Auxiliary Treasurers, please make sure when you receive 2021 dues from members, you are completing transmittals and sending dues to your Grand Treasurers. Grand Treasurers, please send those 2021 dues to our Supreme Treasurer: Penney Howard, P.O. Box 34, Flora Vista, NM 87415-0034. For those Auxiliaries Not In a Grand: Please send your 2021 dues and transmittals to Penney.

7. When a **Supreme District** exists, each Auxiliary must pay its dues to the Supreme District by March 31, 2021. If they have not been paid please make sure the dues are to be paid.

8. AUDITS: Audits for January, February and March are to be done by April 15th.

9. Grand Chaplains and Chaplains of Auxiliaries not in a Grand: Please send year-end reports. They **MUST** be in the hands of Supreme Chaplain Billie Cassidy, 7808 Hwy 412 E, Linden, TN 37096. Email bscassidy@tds.net by June 15, 2021 with the names of all members who passed away this year. Please ensure your members are deceased. We do not want to inadvertently kill off members who are still kickin'. Names of deceased members will be listed in the Supreme Memorial Program and honored at the Supreme Convention

10. HOSPITAL REPORTS: The new Supreme Hospital Commissioner is Ruth Schoonover PSP, 3096 Angela Lane, Oak Harbor, WA 98277-9026, email: rchospmoca@gmail.com. Report those visits. We know each Auxiliary is visiting Veterans outside the Hospitals and Nursing Homes, but we need those reports. Let's keep our District Hospital Commissioners busy sending reports to Ruth since the death of Janis Wimmer. Please be patient with her. She needs time to get everything that Janis had and update files. As a result, Hospital Hour Pins may not be available at the time of your Grand Convention. Recommended Changes to MOC By-Laws

Upon recommendation of the Supreme By-Laws Committee, the following By-law changes are hereby submitted for review, discussion, and vote by the Supreme Scratch in Baltimore, Maryland.

NOTE: Changes to grammar, spelling, punctuation, or Cootie specific titles that did not change the intent of the by-law are not included in these changes. They are an acceptable function of the committee under the advisement of the Supreme Judge Advocate. All such changes were reviewed to ensure the intent was not altered, but rather that the language was cleaned up to reduce ambiguities or lack of clarity. For example, in ALL cases since the basic gathering of a Pup Tent is called a Scratch, whether it be local, Grand or Supreme, it has been modified to always be called a Scratch. The term meeting was stricken throughout.

B-1

Section 101. Active Members.

- B. The application of any member of the Veterans of Foreign Wars who is not a member within the jurisdiction of the Pup Tent in which they are making application to join, shall be referred to the Adjutant of the Grand Pup Tent within which they hold membership in the Veterans of Foreign Wars for the purpose of investigation. A report shall be returned to the Pup Tent in which the application was filed with an appropriate recommendation of approval or disapproval and in the case of disapproval, a statement giving reasons.

Recommendation – Removal

Rationale - This section hinders the VFW by-laws requirement for Posts to investigate and elect Cootie candidates. Once a candidate is cleared by the Post, it is more efficient for the application to be forwarded directly to the Pup Tent of choice.

B-2

Section 102. Active Members-At-Large

Any eligible member not within the jurisdiction of any Pup Tent may become a Member-At-Large upon application to the Adjutant of the Grand Pup Tent within which they reside. In the event of their residence outside the jurisdiction of a Grand Pup Tent, upon application to the Supreme Pup Tent after satisfactory proof of their membership and service in the Veterans of Foreign Wars has been submitted and upon payment of NINE (\$9.00) dollars to the Grand or Supreme Adjutant. In case of the payment of admittance fee to the Grand Adjutant they shall be entitled to become a member of any Local Pup Tent they may choose. Provided, they shall pay additional fees over NINE (\$9.00) dollars as may be in force in the Pup Tent, after making application and being approved as therein provided by said Pup Tent. The Grand Quartermaster will thereupon forward to the Local Pup Tent to which they were admitted the sum of two (\$2.00) dollars and to the Supreme Pup Tent the sum of two (\$2.00) dollars. Likewise, upon payment of Admittance Fee to the Supreme Adjutant, the member may become a member of any Local Pup Tent; provided they shall pay such additional initiation fee over NINE (\$9.00) dollars as may be in force in the said Local Pup Tent. The Supreme Quartermaster will thereupon forward two (\$2.00) dollars to the Local Pup Tent and one (\$1.00) dollars to the Grand Pup Tent.

Recommendation – Removal

Rationale - Grands do not have Members At-Large. Unnecessary section.

B-3

Section 111. Honorable Discharges.

Any member in good standing upon written application to the Seam Squirrel at a regular meeting of the Pup Tent, shall

receive at the next regular meeting of the Pup Tent, an Honorable Discharge signed by the Seam Squirrel and attested to by the Hungry Cootie; provided that at the time of such application, they are not indebted to their Pup Tent. A member thus discharged may be readmitted in the manner prescribed for the selection of new members.

Recommendation – Removal

Rationale – This process is not utilized.

Section 211. Suspension and Revocation of Pup Tent Charter.

- C. Establishment of Trusteeship.** Upon the imposition of any suspension under this section, the Grand Commander shall appoint a trusteeship to consist of from three to five trustees chosen by the Grand Commander, at least one of whom shall reside sufficiently near the Pup Tent, to effectively carry out the business and affairs of the trusteeship and who shall be willing and able to perform such duties. Pursuant to a written grant of powers and limitations, such trustees shall carry on the business and affairs of the Pup Tent during the period of suspension. The business and affairs of the Pup Tent shall be limited to current MOC activities. The actions of the trustees shall be subject to the approval of the Grand Commander who shall submit to the Supreme Commander a written report of the situation and the activities of the Pup Tent under suspension. While under suspension, Scratches shall be held in the name of the Pup Tent except for the sole purpose of the discussion of the cause, effect and removal of the penalty, and no funds of the Pup tent shall be expended or obligations incurred during and while the order of suspension is in force except as may be expended or obligated by the trustees appointed under this subsection. Any trusteeship appointed under these provisions shall remain in office until the suspension is lifted or the charter has been canceled and the Charter with monies and property of the Pup Tent have been recovered and forwarded through the Grand Quartermaster to the Supreme Quartermaster, or otherwise relieved by the Grand Commander.

Recommendation – Remove the identified phrase above.

Rationale – Too restrictive. If the assigned trustees are willing to travel, so be it

B-6

Section 213. Regular Scratches.

The regular Scratches of each Pup Tent shall be held at least once a month at the location designated on the Charter, unless otherwise authorized by special dispensation, and will be called a local Scratch. The Pup Tent Charter must be displayed during all Scratches.

Recommendation – Add the following statement before the last sentence in this section:

Pup Tents may incorporate the use of technology for Scratches provided that additional procedures are adopted pertaining to the conduct of Scratches and that it allows all participating members to communicate with each other simultaneously.

Rationale - Provides for subordinate units to incorporate technology into MOC Scratches/ Meetings. This does not mandate, this only allows.

B-7

Section 219. Consolidation of Pup Tents.

When two or more Pup Tents in good standing desire to consolidate, written or printed notice of such proposed action shall be given to all members in good standing at least two (2) weeks prior to date of meeting for consideration of such proposition in each of said Pup Tents. If such proposition shall then be adopted by a vote of two-thirds (2/3) of the members present and voting at such Scratch, the vote being records by ayes and nays; the fact shall through channels, be certified by resolution of each Pup Tent to the Grand Commander, or if no Grand Pup Tent exists, then to the Supreme Commander. When the resolutions are so approved by two (2) or more Pup Tents, the Grand Commander shall forward said approved resolutions to the Supreme Commander (where no Grand Pup Tent exists, the two Pup Tents shall send them directly to the Supreme Commander) who shall approve or disapprove, depending, and he or she will issue without charge a new Charter reciting the facts of such consolidation and bearing the names of such Pup Tents. The new Charter shall rank from the date of the senior numbered Pup Tent but the number shall be either number of the consolidating units agreed upon by the consolidating Pup Tents, and the new name shall be one agreed on by the consolidating Pup Tents, both of the foregoing having been agreed on by vote of two-thirds (2/3) of the members present and voting of any and all Pup Tents consolidating at a Scratch for the specific purpose of consolidation, due notice of at least two (2) weeks having been mailed all members of said Pup Tent concerned. The property of the consolidated Pup Tent shall be conveyed to the new Pup Tent and become the property thereof. All past officers in each shall be entitled to ranks as of date of service in their respective Pup Tent. Upon the consolidation of Two (2) or more Pup Tents, new officers shall be elected and installed. In the event two (2) or more Pup Tents consolidate, all officers of the consolidated Pup Tents having fulfilled their obligations shall be recognized as past officers, provided, however, the past Seam Squirrels of the consolidated Pup Tents for the purpose of representing either the Pup Tents consolidated, or for the new Pup tent formed by such consolidation at any District or Grand Scratch.

Recommendation – Rewrite as shown below.

Rationale – Clear up ambiguities and poor sentence structure.

When two or more Pup Tents in good standing desire to consolidate, written or printed notice of such proposed action

shall be given to all members in good standing at least two (2) weeks prior to date of Scratch for consideration of such proposition in each Pup Tent. If such proposition shall then be adopted by a vote of two-thirds (2/3) of the members present and voting, the vote shall be recorded by ayes and nays. The result shall be certified by resolution of each Pup Tent and forwarded to the Grand Commander, or if no Grand Pup Tent exists, then to the Supreme Commander. When the resolutions are approved by two (2) or more Pup Tents, the Grand Commander shall forward the approved resolutions to the Supreme Commander (where no Grand Pup Tent exists, the two Pup Tents shall send them directly to the Supreme Commander) who shall approve or disapprove the action. If approved, a new Charter will be issued without charge, reciting the facts of such consolidation, and bearing the names of such Pup Tents. The new Charter shall rank from the date of the senior numbered Pup Tent but the number shall be either number of the consolidating units agreed upon by the consolidating Pup Tents. The new name shall be one agreed upon by the consolidating Pup Tents, as agreed on by vote of two-thirds (2/3) of the members present and voting at a Scratch for the specific purpose of consolidation. The property of the consolidated Pup Tent shall be conveyed to the new Pup Tent and become the property thereof. All past officers in each shall be entitled to ranks as of date of service in their respective Pup Tent. Upon the consolidation of Two (2) or more Pup Tents, new officers shall be elected and installed. In the event two (2) or more Pup Tents consolidate, all officers of the consolidated Pup Tents having fulfilled their obligations shall be recognized as past officers.

B-8

Section 315. Duties of the Shyster.

The Shyster shall give the Seam Squirrel and the Scratch such legal assistance incident to the office, as they may request and perform such other duties as the By-Laws may require.

Recommendation – Remove the words “legal assistance” and replace with “counsel”.

Rationale – Most Shysters are not legally trained and should not be providing legal assistance.

The Shyster shall give the Seam Squirrel and the Scratch such counsel incident to the office, as they may request and perform such other duties as the By-Laws may require.

Section 405. Meeting – Grand Scratch.

- A.** There shall be a meeting of the Grand Pup Tent held at the same time and place as that of the Department Convention of the Veterans of Foreign Wars within whose jurisdiction the Grand Pup Tent exists but the Grand Council may call additional meetings if it so desires.

Recommendation - Removal of the mandate to hold the convention together with the VFW convention.

Rationale - provides for more flexibility and better reflects what is actually taking place. This change also provides for subordinate units to incorporate technology into MOC Scratches/ Meetings. This does not mandate, this only allows.

- A.** There shall be a Scratch of the Grand Pup Tent held once annually within whose jurisdiction the Grand Pup Tent exists. The time and place will be determined by the Grand Commander. Grands may incorporate the use of technology for Grand Scratches provided that additional procedures are adopted pertaining to the conduct of such Scratches and that it allows all participating members to communicate with each other simultaneously.

B-10

Section 405. Meetings – Grand Scratch.

- C.** The Grand Pup Tent may hold an entertainment feature in connection with its stated meeting in the nature of a public Carnival or Mardi Gras to be known as the “Grand Finis la Guerre” parade.

Recommendation – Remove section in its entirety.

Rationale - No one knows what is a “Grand Finis la Guerre” nor is a description available in the ritual. If a Grand still does this, removal from the by-laws does not mandate it cannot take place.

B-11

Section 412. Duty of the Adjutant

- C. Expenditure Vouchers:** They shall prepare on forms as prescribed by Supreme Headquarters in duplicate, all vouchers authorizing the expenditure of Grand Pup Tent monies. Such vouchers shall be numbered in sequence and plainly set forth the name and address to whom the money is to be paid, shall be itemized in detail, what the expenditure is for, shall be approved by the Grand Commander, and the original forwarded to the Grand Quartermaster for payment.

Recommendation – Remove the requirement for specific forms or vouchers to be used within the Grand organization.

Rationale – Procedure for expenditure of funds within Grands should be made pursuant to Grand policies and Generally Accepted Accounting Practices. Moreover, Supreme HQ does not have a mandated form that covers all expenditures. They only have one for travel.

- C. Expenditure Vouchers:** Expenditure of funds shall occur as prescribed by the Grand’s by-laws or policy and dispensed using acceptable banking practices

B-12

Section 413. Duty of the Grand Quartermaster.

- B. Funds, Disbursements of:** They shall expend Grand Pup Tent funds only upon presentation of a proper expenditure voucher which must be numbered in sequence, designate clearly to whom payment is to be made, itemized in detail as to what the expenditure is for, and approved by the Grand Commander.

Recommendation - Removal of an antiquated process

Rationale – Process is not used nor is it required.

- B. Funds, Disbursements of:** They shall expend Grand Pup Tent funds only upon presentation of proper documentation and approved by the Grand Commander.

B-13

Section 416. Duty of the Grand Judge Advocate.

The Grand Judge Advocate shall give the Grand Commander, the Grand Council of Administration and Grand Scratch such legal assistance, incident to their office, as they may request and perform such other duties as the By-Laws may require.

Recommendation – Remove the words “legal assistance” and replace with “counsel”.

Rationale – Most Judge Advocates are not legally trained and should not be providing legal assistance.

The Grand Judge Advocate shall give the Grand Commander, the Grand Council of Administration and Grand Scratch such counsel, incident to their office, as they may request and perform such other duties as the By-Laws may require.

B-14

Section 425. Duty of the Grand Council of Administration.

- D. Meetings, Time and Place:** The Grand Council of Administration shall meet in session not less than twice a year and such other times as directed by the Grand Commander or Council By-Laws provide. The place of meeting shall be at the direction of the Grand Commander unless otherwise specified by the Council.

Recommendation – Include the use of technologies for conducting Council Scratches.

Rationale - This change provides for subordinate units to incorporate technology into MOC Scratches/Meetings. The change does not mandate, it only allows.

The Grand Council of Administration shall meet in session not less than twice a year and such other times as directed by the Grand Commander or Council By-Laws provide. The place of meeting shall be at the direction of the Grand Commander unless otherwise specified by the Council. Grand Councils of Administration may incorporate the use of technology for its sessions provided that additional procedures are adopted pertaining to the conduct of sessions and that it allows all participating members to communicate with each other simultaneously.

B-15

Section 425. Duty of the Grand Council of Administration.

- G. Quorum:** A majority of the Grand Council of Administration present shall constitute a quorum for the transaction of business; provided, however, that there shall be at least seven (7) members present.

Recommendation – Refer the reader back up to section 407 D. for finding the list of Council members.

Rationale – Refers the reader to the listing of council members instead of listing again.

- G. Quorum:** A majority of the Grand Council of Administration present, as described in Sec. 407D, shall constitute a quorum for the transaction of business; provided, however, that there shall be at least seven (7) members present.

B-16

Section 503. Meetings.

The stated meetings of the Supreme Pup Tent shall be held annually at the same time and place as that of the National Encampment of the Veterans of Foreign Wars of the United States.

Recommendation – Remove the reference to National Encampment; remove the stated requirement for same time and place as the national convention; and add the use of technology.

Rationale - The Supreme Convention cannot be held at the same time and place as the VFW Convention. This also updates the language from encampment to convention. The change also provides for incorporation of technology into the Supreme Convention. The change does not mandate, it only allows.

Section 503. Meetings.

The stated meetings of the Supreme Pup Tent shall be held annually at the same general time and place as that of the National Convention of the Veterans of Foreign Wars of the United States. Such meetings may incorporate the use of technology provided that additional procedures are adopted pertaining to the conduct of such meetings and that it allows all participating members to communicate with each other simultaneously.

B-17

Section 504. Eligibility to Office.

All active third degree members in good standing shall be eligible to any Supreme office in the Military Order of the Cootie; provided, however, that said members have been active members of the Military Order of the Cootie for at least three (3) years and that no member shall hold more than one (1) elective office at any one time.

Recommendation – Add clarifier that this applies only to the Supreme organization.

Rationale – Removes the ambiguity of the section.

Section 504. Eligibility to Office.

All active third degree members in good standing shall be eligible to any Supreme office in the Military Order of the Cootie; provided, however, that said members have been active members of the Military Order of the Cootie for at least three (3) years and that no member shall hold more than one (1) elective office in the Supreme Pup Tent at any one time.

B-18

Section 505. Supreme Officers.

C. Supreme Council of Administration: The Supreme Council of Administration shall consist of the following officers: All elected officers (see paragraph A.), the immediate Past Supreme Commander (as long as he is in good standing), Supreme Adjutant, Chief of Staff, Inspector, Hospital Commissioner, Shirt Reader, Provost Marshal, Jimmy Legs, and fifteen (15) additional members, one each to be elected for two (2) years (even numbered districts in even numbered years, odd numbered districts in odd numbered years), by the members present and representing the following districts:

- District No. 1: Maine, New Hampshire, Vermont, Massachusetts, and Rhode Island
- District No. 2: Connecticut, New York, New Jersey
- District No. 4: Maryland, Virginia, West Virginia, Pennsylvania, Delaware
- District No. 5: North Carolina, South Carolina, Georgia, and Florida
- District No. 6: Alabama, Mississippi, Louisiana, Tennessee, and Canal Zone
- District No. 7: Ohio, Indiana, Kentucky
- District No. 8: Michigan, Illinois, Wisconsin
- District No. 9: Iowa, Missouri, Nebraska, Kansas, and South Dakota
- District No. 10: Minnesota, North Dakota
- District No. 11: New Mexico, Colorado, Utah, Wyoming
- District No. 12: California, Arizona, Nevada, Hawaii
- District No. 13: Idaho, Washington, Oregon, Alaska, Montana
- District No. 14: Texas, Oklahoma, Arkansas
- District No. 15: Grand Pup Tent of the Pacific Area
- District No. 16: Grand Pup Tent of Europe

D. Each District will develop a rotational schedule to determine which Grand or Black Division Pup Tent is next in line to have the councilmember. The Supreme Councilmember will appoint a Deputy Council of Administration member from their State to be their replacement in the event of the death or resignation of the Supreme Councilmember. The Senior Vice Councilmember does not become the councilmember.

E. Each District shall elect a Senior Vice Council of Administration Member, and a Junior Vice Council of Administration Member for terms to run concurrent with the Supreme Council of Administration Member, the Senior Vice Member will be from the State next in line for a Supreme Council of Administration Member.

- F. Each District shall hold an annual District Scratch, at a central point, at least thirty (30) days prior to the National V.F.W. Convention and annual Supreme Scratch. The Supreme Council of Administration Member for the District shall preside and the regular form of V.F.W. business procedures shall be used. The District Scratch shall transact all business relative to the District; elect their Supreme Councilmember, Senior Vice and Junior Vice Members, with due respect to the States and in accordance with the approved rotational schedule. Each Pup Tent in the Supreme District Scratch shall be entitled to the same number of delegates as provided for at the Supreme Scratch.
- G. If the Supreme Councilmember is unable to attend the Supreme Scratch or Supreme Meetings, the Senior Vice Councilmember will take the place of the councilmember. In their absence or disability, the Junior Vice Councilmember shall discharge the duties the councilmember.

Recommendation – Replace C through G and add H as shown below,

Rationale - Eliminates the Supreme Districts and places the Grand Commanders as members of the Council of Administration. This change also creates two councilmembers to represent the various separate Pup Tents. Through the use of technology, these councilmembers can effectively administer their responsibilities without the requirement for travel. We must adjust our organization to reflect our decreasing size and empower those who are actually leading our subordinate organizations. Supreme Districts were only figureheads and never provided with a mandate of responsibility. This change does away with an unnecessary layer of bureaucracy which makes our organization flatter and more effective.

- C. Supreme Council of Administration: The Supreme Council of Administration shall consist of the following officers: All elected officers (see paragraph A.), the immediate Past Supreme Commander, Adjutant, Chief of Staff, Inspector, Hospital Commissioner, Shirt Reader, Provost Marshal, Jimmy Legs, all Grand Commanders, and two (2) councilmembers representing the separate Pup Tents. Each councilmember is elected for one (1) year terms
- D. When Grand Commanders are unable to attend the Supreme Scratch or Supreme Meetings, the Grand's Senior Vice Commander will take the place of the Grand Commander. In their absence or disability, the Grand's Junior Vice Commander shall discharge the duties the councilmember.
- E. An East Region Councilmember shall represent all separate Pup Tents east of the Mississippi River and a West Region Councilmember shall represent all separate Pup Tents to the west. In addition to representation, the councilmembers will provide administrative oversight, advice, counsel, and training as may be required by the Supreme organization. Each Region will develop a rotational schedule to determine which Black Division Pup Tent is next in line to have the councilmember-
- F. Each Region shall elect a Vice Councilmember for a term to run concurrent with the Supreme Councilmember-and will be from the Pup Tent next in line for a Supreme Council of Administration Member.
- G. Each Region shall hold an annual Scratch, at a central point, at least thirty (30) days prior to the National V.F.W. Convention and annual Supreme Scratch. The Supreme Council of Administration Member for the Region shall preside and the regular order of V.F.W. business procedures shall be used. Such Scratches may incorporate the use of technology provided that procedures are adopted pertaining to the conduct of such Scratches and that it allows all participating members to communicate with each other simultaneously. The Scratch shall transact all business relative to the Region, including election of the next councilmember and Vice Councilmember; with due respect to the approved rotational schedule. Each Pup Tent shall be entitled to the same number of delegates as provided for at the Supreme Scratch.
- H. If the Supreme Councilmember is unable to attend the Supreme Scratch or Supreme Meetings, the Vice Councilmember will take the place of the Council.

B-19

Section 509. Duty of the Supreme Commander.

- A. The Supreme Commander shall enforce the By-Laws, Rules and Regulations of the Military Order of the Cootie of the United States, and the orders of the Supreme Scratch and the Supreme Council of Administration and for this purpose, he/she may issue such orders as may be necessary. He/she shall preside in the Supreme Scratch and the Supreme Council of Administration, decide all questions of law or usage subject to an appeal to the Supreme Scratch, approve all warrants

properly drawn on the Supreme Quartermaster and shall hold all securities given by the Supreme officers as trustees of the Military Order of the Cootie of the United States. He/she shall appoint immediately after entering upon his/her office, the Supreme Adjutant, Supreme Chief of Staff, Supreme Inspector, Supreme Hospital Commissioner, Supreme Shirt Reader, Supreme Provost Marshal, Supreme Jimmy Legs, Supreme V.F.W. Booster Chairperson, and all other Supreme officers and committees not otherwise provided for, and may remove these officers at his/her pleasure; provided, however, if any such officers are salaried, the appointment shall be subject to the approval of the majority of elected and non-salaried members of the Supreme Council of Administration and such officers may be removed by a majority vote thereof; and shall receive such compensation as the Supreme Scratch may determine from time to time.

Recommendation – Remove the restating of the appointed officers/positions and refer to the previously stated list.

Rationale – Reduce unnecessary redundancies.

Section 509. Duty of the Supreme Commander.

- A. The Supreme Commander shall enforce the By-Laws, Rules and Regulations of the Military Order of the Cootie of the United States, and the orders of the Supreme Scratch and the Supreme Council of Administration and for this purpose, he/she may issue such orders as may be necessary. He/she shall preside in the Supreme Scratch and the Supreme Council of Administration, decide all questions of law or usage subject to an appeal to the Supreme Scratch, approve all warrants properly drawn on the Supreme Quartermaster and shall hold all securities given by the Supreme Officers as trustees of the Military Order of the Cootie of the United States. He/she shall appoint immediately after entering upon his/her office, all appointive officers as listed in Section 505B above, and all other Supreme officers and committees not otherwise provided for, and may remove these officers at his/her pleasure. If any such officers are salaried, the appointment shall be subject to the approval of the majority of elected and non-salaried members of the Supreme Council of Administration and such officers may be removed by a majority vote thereof; and shall receive such compensation as the Supreme Scratch may determine from time to time.

B-20

Section 512. Duty of the Supreme Quartermaster.

Recommendation – Add the new section A to appoint an Assistant Quartermaster (AQ) and renumber the remaining sections accordingly.

Rationale - The position of Tomb Trek Committee chair requires the Cootie to have authority to expend funds, coordinate with external agencies, and commit the organization to contractual obligations. Following both the VFW and MOC by-laws, the Tomb Trek Chair should actually be an AQ to properly carry out those responsibilities; otherwise the Supreme QM must carry out these responsibilities.

- A. Upon entering into office, the Supreme Quartermaster may appoint an Assistant Quartermaster, subject to the approval of the Supreme Council of Administration.

B-21

Section 513. Duty of the Supreme Judge Advocate.

The Supreme Judge Advocate shall be prepared at all times to give such legal counsel and advice as the Supreme Commander or Supreme Scratch may require. After each Supreme Scratch, he/she shall review the changes made in the By-Laws and see to it that all proper changes are made on the revision of the printed By-Laws. In this connection, he/she shall have the power to make necessary corrections to errors in spelling, grammar, punctuation and/or typographical arrangement without the necessity of a formal amendment to effectuate the same. He/she shall perform such other duties incident to his/her office.

Recommendation – Change the reference of legal counsel to parliamentary.

Rationale - Supreme Judge Advocate serves as counsel on interpretation of the by-laws and parliamentary procedure, not as a legal advisor.

Section 513. Duty of the Supreme Judge Advocate.

The Supreme Judge Advocate shall be prepared at all times to give such legal parliamentary counsel and advice as the Supreme Commander or Supreme Scratch may require. After each Supreme Scratch, he/she shall review the changes made in the By-Laws and see to it that all proper changes are made on the revision of the printed By-Laws. In this connection, he/she shall have the power to make necessary corrections to errors in spelling, grammar, punctuation and/or typographical arrangement without the necessity of a formal amendment to effectuate the same. He/she shall perform such other duties incident to his/her office.

B-22

Section 526. Duty of the Supreme Trustees.

- D. In the event the Council of Administration directs or the Supreme Trustees require an additional independent investigative audit it will be the responsibility of the Supreme Trustees to select and recommend an auditing firm to do the independent audit and report the findings to the Council of Administration.
- E. The Supreme Trustees shall conduct a line-by-line audit of the books on a month by month basis at each audit session. It shall be the responsibility of the Supreme Quartermaster to provide the Supreme Trustees with the necessary records of the Supreme Pup Tent to insure that the audit can be conducted in a timely fashion.
- F. Travel allowance will be based on the rates prescribed by the current Supreme Policy, and shall be paid to the Supreme Trustees for each audit.

Recommendation – Delete sections D and F and renumber subsection E.

Rationale – This (subsection D) is a process inherent to the office of Trustee and not necessarily a policy that requires a by-laws mandate. Like any other item of business, if the trustees discover inconsistencies that require an external audit, they will bring it to the attention of the Council. If councilmembers discover inconsistencies in financial reports, they should bring it to the attention of the Trustees for further inquiry. (Subsection F) Trustees are Supreme Officers and do not require a separate budget line item. In the event travel is required, the funding can come from Supreme Officer travel line item which already exists.

B-23

Section 601. Ritual – Distribution of.

- A. The Ritual of the Military Order of the Cootie shall be supplied only to the Seam Squirrels of subordinate units, who shall be responsible for the distribution of rituals to the proper persons entitled to receive them.

Recommendation – Reword this section as shown below.

Rationale - Clarifies Seam Squirrel responsibility to distribute the ritual.

- A. Seam Squirrels shall be responsible for the distribution of rituals to the proper persons entitled to receive them.

HONOR THOSE WORTHY OF HONOR

It was so horrific that historians named it “the war to end all wars.” It began with the assassination of the heir of the Austro-Hungarian Empire and its desire for revenge. It was encouraged by other nations eager to try out their new war machines and to settle old scores. In the aftermath, there were 40 million casualties – killed, wounded, and missing. This was World War I.

But it was the industrialization and dehumanization of this war that made it so terrible. The individual heroism of soldiers and sailors who answered their nation’s call seemed lost in the mass destruction brought on by industrialized war. Battling Dreadnoughts, poison gas attacks, and massed artillery barrages eclipsed the individual sacrifices of so many.

Despite the inglorious way so many lives were snuffed out, these brave soldiers and sailors were mourned no less by those who loved them. And millions of families yearned and prayed for the missing remains of their loved ones to someday be returned. And, for a time, the bravery and sacrifices of these men were honored by the nations they served.

The recent discovery of a mass WWI grave site has revealed that such bravery and sacrifice are not honored as they used to be. A French archeological team led by Pierre Malinowski, located the final resting place of the doomed 111th Reserve Infantry Regiment from Baden, Germany. The entire regiment went missing in May 1917, when all 270 of its soldiers were buried alive in the Winterburg Tunnel during the Second Battle of the Aisne. French artillery sealed both entrances of the tunnel, condemning all the soldiers inside to an agonizing death.

The army did manage to rescue three soldiers before they died. One of the survivors, Karl Fisser, related the fate of those left behind. *“Everyone was calling for water, but it was in vain. Death laughed at its harvest and Death stood guard on the barricade, so nobody could escape. Some raved about rescue, others for water. One comrade lay on the ground next to me and croaked with a breaking voice for someone to load his pistol for him.”*

Pierre Malinowski, eager to bring these men their due honor, explained, *“These were farmers, hairdressers, bank-clerks who came willingly to fight this war, and then died in a way that we cannot begin to comprehend.”*

But when Malinowski contacted the German War Graves Commission, he was shocked to

find a total lack of interest on their part. The Commission's spokesperson, Diane Tempel-Barnett, stated, *"To be honest, we are not very excited about the discovery. In fact, we find it all most unfortunate."*

To think that one day the nation these men fought and died for would not even consider their long-lost remains worth their attention is sickening. Far worse, that they'd deem them a *"disturbing intrusion"* on their lives is heart-breaking. Why did Diane Tempel-Barnett find the discovery not worth her interest? Does such sacrifice for one's country reveal her own shallowness? Does their heroism and bravery – though snuffed out so callously – unmask her own weakness, selfishness, and cowardice by comparison?

Our spineless popular culture loves to destroy the heroes of the past. In fact, pop culture must do so, for such heroes expose their own hollowness. And, in place of real heroes, pop culture adores overpaid celebrities, musicians, and athletes who exhibit none of the virtues essential to the building and preserving of a nation.

President John F. Kennedy stated, *"A nation reveals itself not only by the men it produces but also by the men it honors, the men it remembers."* America cannot allow pop culture to determine the course of its future, or it will have no future. We must honor those whose hard work, sacrifice, and bravery who have secured us our freedoms and safety. And we must expose the hypocrisy, corruption, and cowardice of our pop cultural icons.

"Remember those who led you, who spoke the word of God to you; and considering the result of their way of life, imitate their faith" (Hebrews 13:7).

PRAYER: Dear Father in heaven, please bless our troubled and misled nation. Please pour forth Your Holy Spirit upon us and breathe a revival in our hearts and across our land. Almighty Father, just as You perform a miracle among the trees and plants in the northern hemisphere – causing them all to spring to life after a long winter of death, perform that miracle in our hearts. May Your Holy Spirit raise us all from death in sin to newness of life in Christ Jesus! Create in us, O God, a hunger and thirst for righteousness and truth – as well as a loathing for sin, perversion, and hypocrisy. Bring us, O God, into the saving embrace of Your holy Son, we pray. Amen.



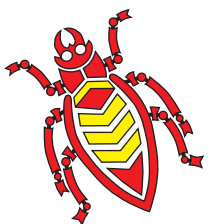
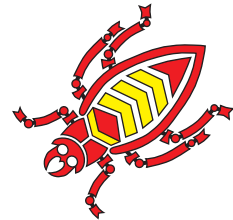
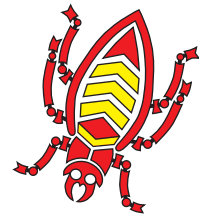

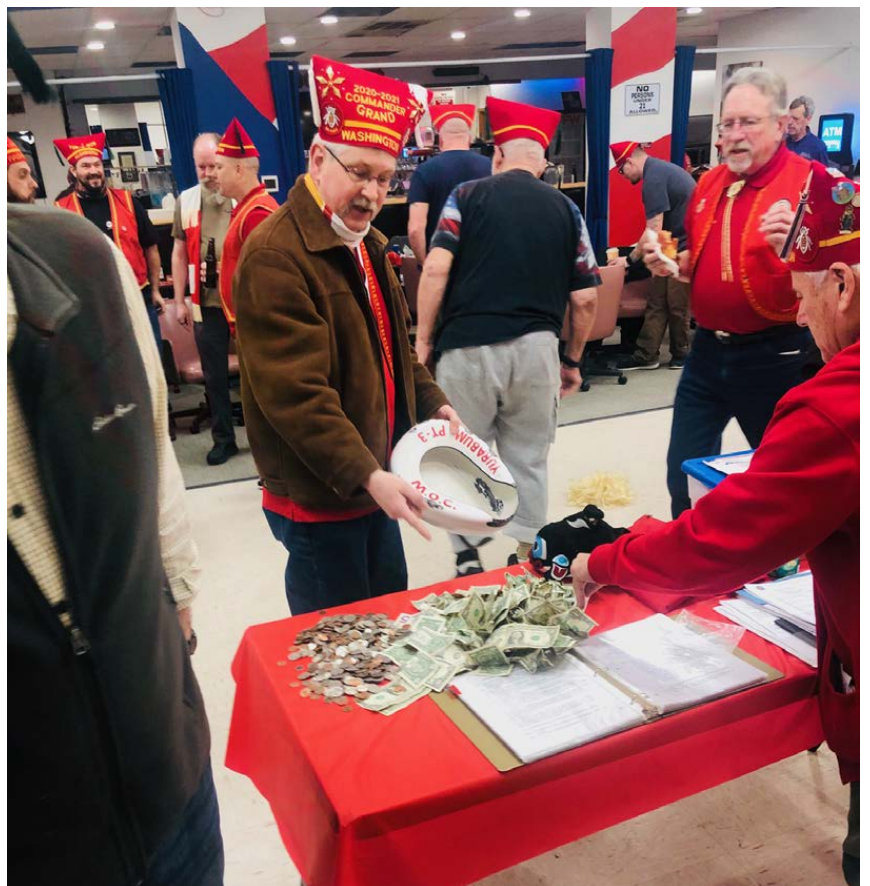
Pup Tent 3 & Pup tent 11 joined forces to complete *"degree work"* together. It was a Lousy time with several taking backward steps.

Blood has also been donated by several. We are back in the Seattle VA as of last week and we look forward to getting back into our community!!!



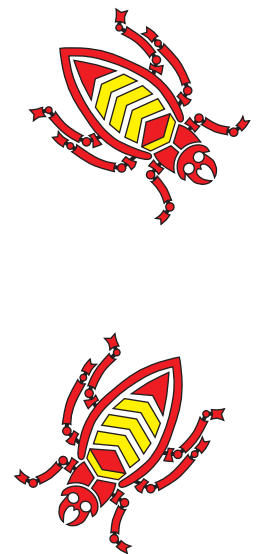
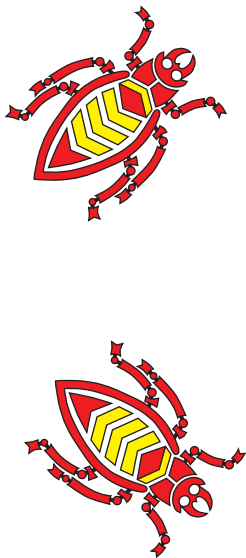
